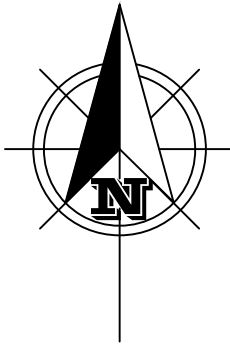


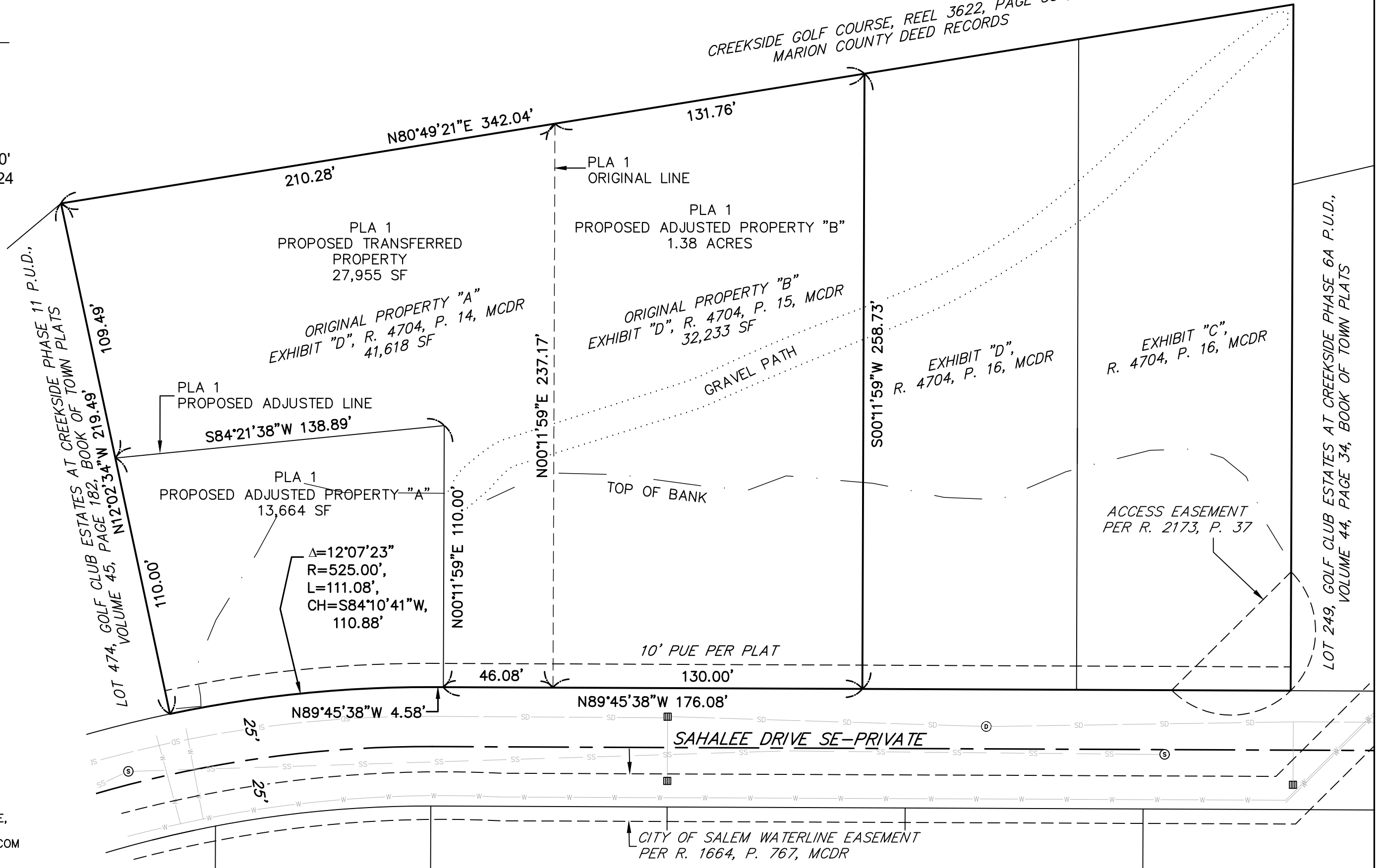
PROPOSED PROPERTY LINE ADJUSTMENT (1 OF 3)
