Good Morning,

I can only evaluate Tree Removal Permits based on the criteria in the Code. There are two applicable sections for Significant Trees:

- (1) *Hazardous tree.* The tree removal is necessary because the condition or location of the tree presents a hazard or danger to persons or property; and the hazard or danger cannot reasonably be alleviated by treatment or pruning, or the tree has a disease of a nature that even with reasonable treatment or pruning is likely to spread to adjacent trees and cause such trees to become hazardous trees.
- (2) *Repair, alteration, or replacement of existing structures.* The tree or native vegetation removal is reasonably necessary to effect the otherwise lawful repair, alteration, or replacement of an existing structure, the footprint of the repaired, altered, or replacement structure is not enlarged, and no additional riparian corridor area is disturbed beyond that essential to the repair, alteration, or replacement of the existing structure.

The evidence submitted indicates some of the trees are required to repair the structure, but yet no repairs are proposed. The remaining tree (front yard) is not identified by the engineer to be removed for any repairs.

An Arborist is a person who cares for trees, can diagnose and treat insects disease or other health related issues. The information submitted does not suggest the trees are a hazard or dangerous, which can not be alleviated by treatment of pruning.

Lastly, after speaking to our legal counsel, the trust documents are needed showing you can sign on behalf of the trust.

Therefore, the previous incomplete letter has not been addressed and the application is still deemed incomplete.

Your application, which is incomplete, will be deemed complete upon receipt of one of the following:

- (1) All of the missing information.
- (2) Some of the missing information and written notice from you (the applicant) that no other information will be provided.
- (3) Written notice from you (the applicant) that none of the missing information will be provided.

You have 180 days (September 10, 2024) from the date the application was first submitted (March 14, 2024) to respond in one of the three ways listed above, or the application will be deemed void.

Tree and vegetation removal permits (SRC 808.030)	Decision Criteria under SRC 808.030(d)(1) has not been adequately addressed for all four trees. The Engineer Report identifies three trees potentially causing damage to the dwelling. The decision criteria has not been addressed regarding the extent of the repairs being proposed. Lastly, the report in does not identify the tree in the front yard in the same manner and does not appear to meet the criteria for removal.
