MCSR 30338 TRANSFERS APPROXIMATELY 1.00 ACRES FROM PARCEL 2 (TAX LOT 400) TO PARCEL 3 (TAX LOT 200), CREATING TAX LOT 401.

MCSR 24936 APPEARS TO OFFICIALLY DEDICATE THE SOUTHEASTERLY 50.04 FEET OF THE SUBJECT PROPERTY TO MARION COUNTY, COUNTY ROAD 847 – HOLLAND DRIVE.

MCSR 26300 SEPARATES A 1.50 ACRE PARCEL FROM THE SUBJECT PROPERTY IN 1977.

MCSR 30338 TRANSFERS APPROXIMATELY 1.00 ACRES FROM PARCEL 2 (TAX LOT 400) TO PARCEL 3 (TAX LOT 200).

TAX LOT 401:

TAX LOT 500:

A PORTION OF PARCEL 2, R. 4583, P. 227, MCDR, BEING ALSO A PORTION OF THE MOST SOUTHWESTERLY PARCEL DEPICTED IN MCSR 10020 & MCSR 6545a.

MCSR 24936 APPEARS TO BE THE FIRST SURVEY TO DISREGARD THE EASTERLY LINE OF TAX LOT 500, WHERE IT IS DEPICTED AS A DASHED LINE AND LABELED WITH RECORD DIMENSIONS. IT ALSO APPEARS THAT NO MONUMENTS WERE FOUND AT EITHER THE NORTHWEST OR SOUTHEAST END OF THIS LINE.

THE NORTH SANTIAM HIGHWAY (HWY 22) BISECTS THE MOST SOUTHWESTERLY PARCEL OF MCSR 10020, THEREBY CREATING THE SOUTHWESTERLY BOUNDARY OF TAX LOT 500. THIS BOUNDARY IS FURTHER AMMENDED IN MULTIPLE RIGHT-OF-WAY DEDICATIONS OVER THE YEARS, RESULTING IN THE PROPERTY BEING REDUCED IN SIZE BY MORE THAN 5.43 ACRES, AND RESULTING IN A 2.64 ACRE PARCEL.
