

# **Certification of Trust for the Kalb Joint Revocable Living Trust dated June 20, 2018**

Pursuant to ORS 130.860 - Certification of Trust, this Certification of Trust is signed by all the currently acting Trustees of the Kalb Joint Revocable Living Trust dated June 20, 2018, who declare as follows:

1. **Settlors:** The Settlers, also known as Grantors, Trustors, or Trustmakers, are David G. Kalb and Pamela S. Kalb. The trust is revocable by the Grantors, acting jointly and not separately.
2. **Trustees:** The Trustees of the trust are David G. Kalb and Pamela S. Kalb. The signature of one Trustee is sufficient to conduct business on behalf of the trust.  
**Successor Trustees:** The Successor Trustees of the trust are:  
Karen C. Irvin then  
Kevin C. Kalb.
3. **Tax ID Number:** The tax identification number of the trust is the social security number of either David G. Kalb or Pamela S. Kalb.
4. **Mailing Address:** The mailing addresses of the currently acting Trustees are:

5. **Title:** Title to assets held in the trust shall be titled as:  
David G. Kalb and Pamela S. Kalb, Trustees, or their successors in interest, of the Kalb Joint Revocable Living Trust dated June 20, 2018, and any amendments thereto.
6. **Trust Powers:** The trust powers include at least all those trust powers contained in the Oregon Uniform Trust Code set forth in ORS 130.650 through ORS 130.730. The powers of the Trustees include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage and deal with real and personal property interests.
7. **Alternative Descriptions:** Any alternative description shall be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust.
8. **Revocability, Modification or Amendment:** Acting jointly, Settlers have the absolute right, at any time and from time to time, to amend, restate, or revoke any term or provision of the trust agreement in whole or in part. To be effective, any amendment, restatement, or revocation must be in a written instrument signed by both Settlers and delivered to the Trustee during the Settlers' lifetime.

9. Excerpts Upon Request: Excerpts from the trust agreement that establish the trust, designate the trustee and set forth the powers of the Trustee will be provided upon request.
10. Third Party Reliance: The terms of the trust agreement provide that a third party may rely upon this Certification of Trust as evidence of the existence of the trust and is specifically relieved of any obligation to inquire into the terms of the trust agreement or the authority of the Trustee, or to see to the application that the Trustee makes of funds or other property received by the Trustee.
11. Current Status: The trust is currently in existence and has not been revoked, modified or amended in any way that would cause the representations in this Certification of Trust to be incorrect.
12. State of Jurisdiction: The state or other jurisdiction under the laws of which this trust was formed is Oregon.

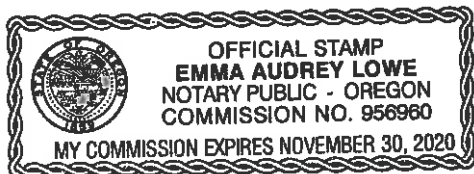
