Hi Olivia,

I am attaching a site map.

We will be grinding the stumps and can replace the trees with new trees if mandatory, however, it is a very shaded and overgrown area from surrounding trees behind us so there will be no direct sun to that area. By the time the area will be cleared off, I feel the best time to plant other trees if needed would be early next spring for their best chance of surviving.

Thank you for considering our proposal for removal for both the 3 trees and the single tree in the NE corner. The inside damage to our ceilings and walls continues to get worse as the roots grow. As I said before, we are only wanting to remove these trees because of the damage they are causing to our house and the neighbor's house.

Our engineer has told us that our inside damage is definitely being caused by the tree roots because all 4 of these trees are very close to our houses with wide spreading roots.
