Hana,

Thank you for reaching out. That would be a class 2 minor historic design review. The application form needs to be signed by the property owner, or if the applicant signs, then the owner needs to provide written consent (email will work). Generally, it is simpler for the owner to sign. We will also need a copy of the deed.

The worksheet is at the last page of the attached review packet. In addition to the solar panels, the other item that should be described is exactly where any of the power apparatus will be located. Tucked away to the sides or rear are historically sensitive approaches.

I also created a customized sheet for the review criteria for this project. I looked at the solar submittal, and it doesn't appear that any panels are proposed for the front of the house, which is beneficial. Please ensure it says that on the response, and shows the locations on submitted plans (you can use generally the same plans submitted for your current application.

You can create a new class II historic design review, residential, in the planning portal online, but if you want, you can also email me the documents, and I can create a folder for you.
