Condition 6 of SPR-ADJ20-48 indicated the following: Pursuant to SPR-ADJ20-48 Condition 6: At least one pedestrian connection meeting the design and materials requirements of SRC 800.065(b) shall be completed from the buildings on the subject property to the public sidewalk on Kuebler Boulevard SE when street improvements are constructed on Kuebler Boulevard SE. As the construction of the pedestrian connection was conditioned, the required connection cannot be eliminated through a Class 2 Adjustment per SRC 250.005(a)(2)(I). Either a variance can be sought to eliminate the standard with the written statement needing to address the applicable approval criteria or this condition can be carried forward with this application. If applicant intends to carry forward the condition, then the feasibility of the connection | The applicant has revised the plans to provide a partial pedestrian connection to Kuebler Blvd, with a speed bump on the side of the pedestrian connection where vehicles enter the pedestrian connection, with an easement for future extension of the pedestrian connection when Kuebler Blvd has a safe route for pedestrians to be connected to. This item is resolved. |
