Thank you for notifying Oregon Department of Transportation (ODOT) of this proposal located at 2300 Commercial Street NE expected to occupy tax lots 3100, 3200, 3300, and 3400. Please include the following comments in the public record and notify ODOT of the decision by sending a copy to myself and odotr2planmgr@odot.oregon.gov.

The proposed development is adjacent to Commercial St NE which is Salem Highway No. 72 (OR99EB) and under the jurisdiction of ODOT. The attached site plan indicates this development will replace the NE corner of Grove and Commercial ADA ramp and all sidewalk along the Commercial Street frontage. ODOT recommends requiring that the existing access between Lots 3300 and 3400 be completely removed and replaced with curb and buffer consistent with adjacent sections.
