Appendix C to 109-012 – Source Control Installations Form

Description of facility operation; types of chemicals and processing materials received and used; locations of materials handling and storage areas; and ultimate method of disposal of waste products, spills, wastewater, and stormwater.

Facility operation - The building is designed to have a containment system in the event of an oil leak. The new and used oil tanks are located in recessed slabs to control any spill. This is then piped to the service pits. These pits are designed to contain the oil until the removal company can be brought in to remove the contained oil. Any final clean up is then mopped up and the mop cleaned in the mop sink which does have an oil / water separator. The floor slab is sealed throughout.

Chemicals - Type of liquids being stored in the tanks are Class IIIB Lubricants only. The only other chemicals in the shop are washer fluid, and coolant.

Disposal - Take 5 recycles all the used oil and filters and do not "dispose" of them.
