Hello.

I have two comments for this filing.

- There's an existing underground 7.2 kV power line that enters the site (originates at pole C8207C-82 on the west side of Turner Rd.), crosses the 4870 property, and feeds the 4880 property. The 7.2 kV power line may be under the proposed building location (on the south side). PGE equipment cannot be placed under a building. If the locations are in conflict, either the power line or the building will need to be moved.
- If one does not exist, PGE will need a dedicated easement to cover our facilities (conduit, vaults, transformers, etc.) both on and crossing the 4870 property. In accordance with OPUC (Oregon Public Utility Commission) Rule C, "customers should provide rights of way and easements for construction, maintenance, repair, replacement, or use of facilities necessary for the supply of electricity. Customers shall also grant PGE free and unrestricted access to the premises at all reasonable times for inspections, testing, repair, removing, or replacing existing facilities."
