Britany,

I need some clarification. SRC 806.035(n) states 'For purposes of these standards, the area of an off-street surface parking area is the sum of all areas within the perimeter of the off-street parking area, including parking spaces, aisles, planting islands, corner areas, and curbed areas, but not including interior driveways and off-street loading areas.' The plans you provided appear to not

include corner areas and planting islands. The parking area for Building 1 was calculated at 49,630 square feet and Building 2 at 51, 585 square feet.

Since the plans don't show they meet the standard for both buildings, Condition 16 (maybe 17) will need to be placed on the decision to ensure the 40% standard (SRC806.035(n)(1)(c)) is met. Just to clarify, the intent of the applicant is to meet the 40% for each building?

Please let me know if that is the intent and I will issue the decision this week.
