Please add the following comments to your response to the applicant.

- There are three vaults in the sidewalk/landscape area on the east side of the existing driveway just south of Blossom Dr. The southern-most vault is PGE equipment and provides power to the recently constructed apartment complex. However, the vault does not appear on the site plans (L1.1 and L2.2) contained in the applicant's documents.
- The space where the existing vault should appear is occupied by a proposed water quality swale. The PGE vault needs to remain in place and cannot be surrounded by a water quality swale. Relocate swale south of the PGE vault.
- Construction of water quality swale south of existing PGE vault may reduce the soil/cover depth above PGE lines. Construct water quality swale so as to maintain a minimum 36" cover depth above PGE lines.
