ARTICLES OF ORGANIZATION (continued)

ARTICLE 9.

A) The Limited Liability Company shall indemnify to the fullest extent permitted by the Oregon Limited 'Liability Company Act, any person who has been made, or is threatened to be made, a party to an action, suit, or proceeding whether civil, criminal, administrative, investigative, or otherwise, including an action, suit, or proceeding by or in the right of the Limited Liability Company, by reason of the fact that the person is or was a member of the Limited Liability Company, or a fiduciary within the meaning of the Employment Retirement Security Act with respect to an employee benefit plan of the Limited Liability Company, or served at the request of the Limited Liability Company, an employee benefit plan of an other Limited Liability Company, corporation, partnership, joint venture, trust, or other enterprise.

B) The personal liability of members to the Limited Liability Company for monetary damages for conduct as a member shall be limited to the fullest extent permitted by the Oregon Limited Liability Company Act.
