THE PURPOSE OF THIS SURVEY IS TO PARTITION THE LANDS DESCRIBED IN R. 4022, P. 041, R. +443.F. - 504.MD R. 4081, P. 276 INTO 3 PARCELS, AS ALLOWED IN PARTITION CASE NO. PARTIS-11. THE BASIS OF BEARING WAS HELD ALONG THE NORTH LINE OF SUNSTONE SUBDIVISION PHASE 3.

THE WEST BOUNDARY MONUMENTS RECOVERED FIT THE LINE BETWEEN THE NORTHEAST CORNER OF SUNSTONE SUBDIVISION PHASE 3 AND THE SOUTH WEST CORNER OF ROSEBROOKE AS RECORDED IN VOLUME 40, PAGE 14 MARION COUNTY BOOK OF TOWN PLATS.

I RETRACED THE SOUTH LINE OF LOT 9 OF ROSEBROOKE AT RECORD BEARING AND DISTANCE. I RECOVERED THE REMAINING MONUMENTS ON THE SOUTH LINES OF ROSEBROOK AND WOODSDE FOR THE NORTH LINE OF THE SUBJECT PROPERTY, SAID LINE WAS EXTENDED EASTERLY TO THE WEST LINE OF WOODSIDE DRIVE SE.

I USED MONUMENTS A AND F TO RETRACE THE CENTERLINE OF WOODSIDE DRIVE SOUTHEAST AND OFFSET THAT RECORD DISTANCE, PER SUNSTONE SUBDIVISION PHASE 3, INTERSECTING THE MORTHLENG OF THE SUBJECT PROPERTY TO SET THE NORTHEAST CORNER AND RETRACE THE WEST RIGHT OF WAY OF WOODSIDE DRIVE SOUTHEAST.

I WAS UNABLE TO RECOVER CENTERLINE MONUMENTS OF MILDRED LANE SE BETWEEN THE INTERSECTIONS OF MARSTONE COURT SE AND WOODSIDE DRIVE SES THI MARION COUNTY SE WAS UNKNEW 54272 UNION GENOMED MONUMENT OF AT THE INTERSECTION OF MARSTONE COURT SE AND MILDRED.
