


**NARRATIVE:**

The purpose of this survey and map was to monument, illustrate, describe and prepare the final map for the City of Salem Planning Partitioning Case No. 94-27P, as shown hereon. Basis of bearings and monumentation was obtained from the survey and map of DOUBLE TREE INDUSTRIAL PARK - PHASE I, as recorded in Volume 38, Page 15, Book of Town Plats, Marion County, Oregon. Positions for setting the missing boundary monuments were computed using the found monuments at plat courses. Interior monuments were set on lot lines using clients' approved Preliminary Partitioning Design. Equipment used for this radial survey was a GTS-4B total station.
