- 2) Written Statement and/or Arborist Report: The written statement or arborist report shall address the approval criteria in SRC 808.030(d) (Ex. hazardous tree, required for building maintenance, water dependent activity, and riparian restoration).
- 3) Additional items that may be submitted or requested: Statement from a structural engineer, pictures; additional items required for riparian restoration projects; any other information that may aid in the review of this application.

Appeal and review

The decision on a Tree Removal Permit shall be the final decision of the City, may not be appealed, and is not subject to City Council Review under SRC 300.1050.

RE: City Tree Removal – 5559 Lone Oak Road SE

Emerio Design represents the applicant for an attached single-family (Townhouse) residential subdivision proposed at 5559 Lone Oak Road SE in Salem, Oregon. This application proposes to preserve 34.9% of the total trees on the subject property. In addition to tree preservation and removal associated to the subdivision development, the applicant proposes to remove 14 total trees which conflict with the required right-of-way improvements on the west side of Lone Oak Road SE. Of the total 14 trees shown to be removed due to Lone Oak ROW improvements, 10 have a DBH of 10" or larger and described below. There are no reasonable alternatives to removal of these trees, as the improvements are required by the city and the trees would be in travel lanes, sidewalk, bike lane, or grading areas for improvements.

Tree **50560**, a **12**" dbh (**Sweet Cherry**) is proposed for removal under criteria 8 of Sec. 86.090.(a). The reason the tree must be removed is it conflicts with the required pavement, grading, curb, sidewalk, and bike lane construction for the **Lone Oak Road** widening and improvement. Due to the location of the tree, there is no way to accomplish the required street improvements while preserving the tree.

Tree **50561**, a **11**" dbh (**Sweet Cherry**) is proposed for removal under criteria 8 of Sec. 86.090.(a). The reason the tree must be removed is it conflicts with the required pavement, grading, curb, sidewalk, and bike lane construction for the **Lone Oak Road** widening and



improvement. Due to the location of the tree, there is no way to accomplish the required street improvements while preserving the tree.

Tree **50564** an **11**" dbh (**Sweet Cherry**) is proposed for removal under criteria 8 of Sec. 86.090.(a). 


