Under the Salem Revised Code (SRC) section 530.040, Motor Vehicle and Manufactured Dwelling and Trailer Sales is not a permitted use in the FMU Adaptive Use zone. **No on-site sales, display, and storage of vehicles is allowed at the subject property**. The dealer may operate only an office at this location, which is classified as a home occupation per SRC 400.125(b). The office must comply with all special use standards for a home occupation in SRC 700.020.
