

STATUTORY WARRANTY DEED

Dragonhopper LLC, an Oregon limited liability company, which acquired title as Dragonhopper, LLC, Grantor, conveys and warrants to W3RE, LLC, an Oregon limited liability company, Grantee, the following described real property, free and clear of encumbrances except as specifically set forth below, situated in the County of Marion, State of Oregon:
