Good Morning Brandon,

On the appeal for 1341 Waller Street, if at all possible I would like to avoid sending out a public hearing notice if the appeal will ultimately be able to be withdrawn based on an agreement on the waterline being reached. To that end, I was wondering if you'd be willing to grant a 30-day extension to the 120-day rule to November 6<sup>th</sup> in order to allow for time to get the waterline design details together and Public Works' approval of the design exception before public notice has to go out. Otherwise, the request for comments for the hearing will need to be mailed out today and the public hearing notice will need to be mailed out tomorrow.
