Hi Zach,

The Survey Division of Development Services (formerly Public Works) performed a second completeness review on the PLA items submitted. The following completeness items have not been addressed:

- 1. **Draft PLA Deeds:** The draft PLA deeds submitted do not meet the form approved by the PW Director; specifically, they should include:
  - a. Legal descriptions of the adjusted property(ies) and the transacted property prepared and sealed by an Oregon-registered Professional Land Surveyor.
  - b. The City of Salem approved PLA Deed Template is attached for reference.
- 2. **Tentative Plan:** The tentative site plan does not comply with SRC 205.055(c), the following items are missing:
  - a. The dimensions and areas of the units of land before and after the proposed property line adjustment. It appears the applicant is intending to use an existing conditions plan to meet this requirement rather than a draft record of survey.

Your application, which is incomplete, will be deemed complete upon receipt of one of the following:

(1) All of the missing information.

(2) Some of the missing information and written notice from you (the applicant) that no other information will be provided.

(3) Written notice from you (the applicant) that none of the missing information will be provided.

You have 180 days from the date the application was first submitted to respond in one of the three ways listed above, or the application will be deemed void.
