1. Permitted work shall comply with the Salem Revised Code, Design Standards, City Standard Construction Specifications, applicable state and federal regulations, and other applicable requirements.
 2. Permittee shall indemnify, defend and save harmless the City of Salem, its officers, employees and agents, from any and all claims arising out of or in connection with work under this permit.
 3. Utility locations are based on record information and should be field-verified. Call 1-800-332-2344 at least 48 hours prior to construction for on-site locating of utilities.
 4. Permittee shall comply with the signing requirements of the "Manual of Uniform Traffic Control Devices" (MUTCD) and the "Oregon Temporary Control Handbook" and to the satisfaction of the City Traffic Engineer.
 5. At least 24 hours prior to each day of work in the public right-of-way, permittee shall contact the Police And Fire Communications Center (503-588-6123); Salem/Keizer School District (503-399-3108); and Transit District (503-588-5468).
 6. The City Traffic Engineer, or their designee, reserves the right to revoke or modify the submitted traffic control plan. In addition, should a problem arise as a result of the approved traffic control, additional traffic control may be required at the permittee's expense.
